SUPPLEMENTAL STUDENT SUPPORT ASSISTANCE

When/how will students be notified that their Supplemental Student Support Assistance funds are on their way?

- Students who remain enrolled on September 1, 2021 in at least 3 units will be mailed a check in the amount of \$1,000. Students should check their Banner Web to ensure that their mailing address is correct. Students should expect their check to arrive by mid-September.

Can Students use Supplemental Student Support Assistance funds to purchase things off campus?

- Yes, these funds were created to assist students with food, gas, housing, or child-care issues that may have been Pandemic induced.

FAQ - ADDITIONAL DETAILS

Will these funds impact a student's financial aid award?

- No, these are supplemental, one-time funds, and they do not impact financial aid, scholarships, or any other program funds they may already receive.

Will students have to pay the bookstore voucher or Supplemental Student Support Assistance money back?

- No, these are one-time supplemental awards.

Should students still fill out a FAFSA or Dream Act Application?

- Yes! The FAFSA and Dream Act are separate processes for funding. Students should still fill out the FAFSA or Dream Act application.
- The Supplemental Student Support Assistance funds are additional funds available to students.
