

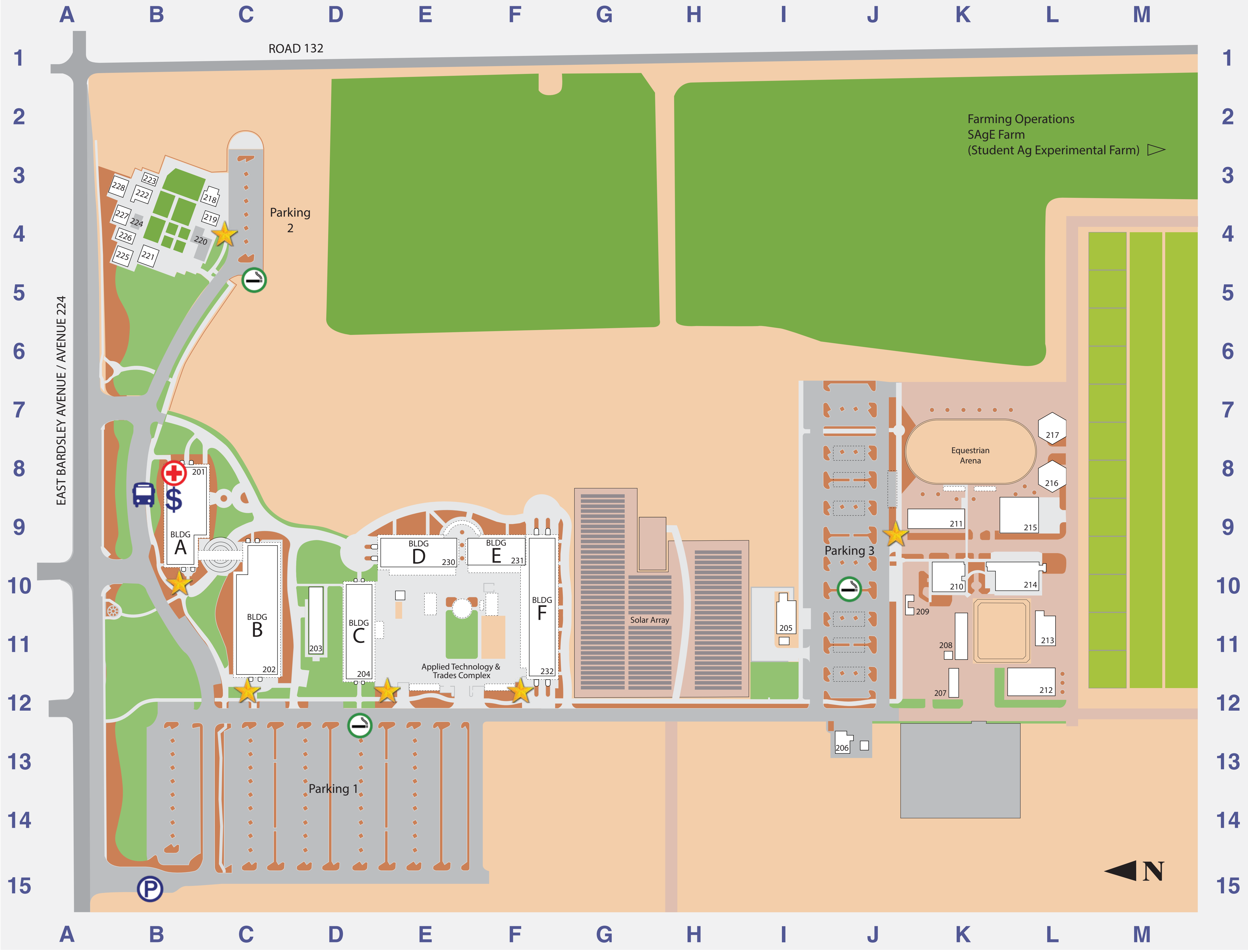

NO TRESPASSING OR LOITERING

Violators will be prosecuted per PCs 487, 555, 602, 602.8 and CA Fish & Game Code Section 2016, 2018.

NO SMOKING/VAPING

Per COS A.P. 3570, smoking, the use of tobacco products, or the use of any instrument that allows the inhalation of psychoactive substances, including vaping devices, is prohibited on District property except in designated areas in parking lots.

LEASH LAW

Pets and emotional support animals, excluding service animals as defined per COS A.P. 3440, are not allowed inside COS facilities. Domesticated animals in exterior public areas must be accompanied by owner and secured on a leash. Dog laws will be strictly enforced per CA Food & Agr. Code 31101-04.

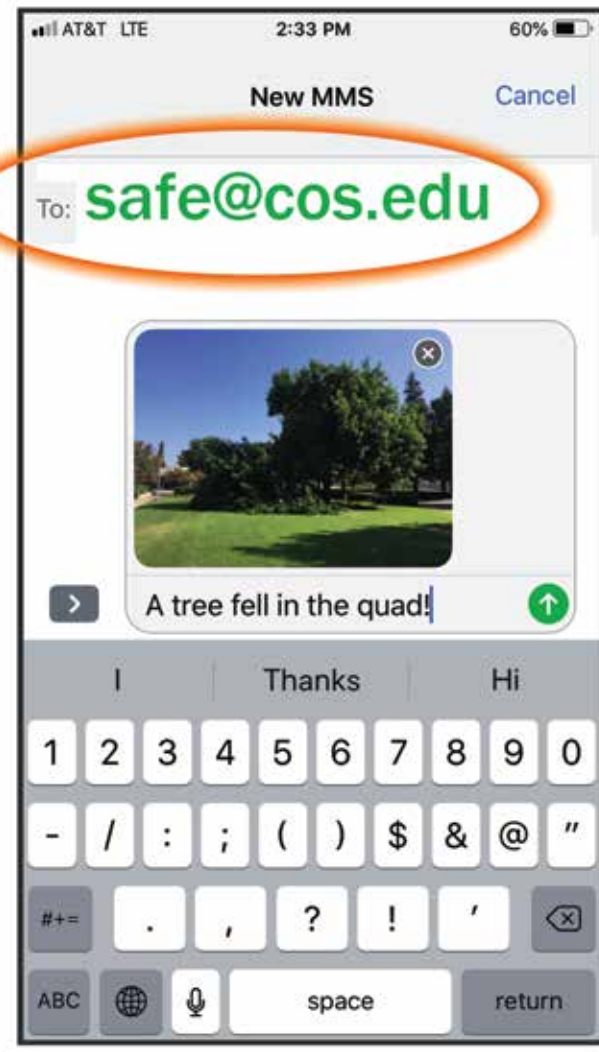
NO RIDING
