	Course Objectives
1	explain the history and evolution of multiculturalism in the U.S. and the challenges presented by a multicultural society.
2	identify then compare and contrast policing methodologies known as community policing and public relations.
3	describe the law enforcement service model known as Community Oriented Policing and Problem Solving (COPPS) and how it relates to effective citizen-police crime prevention relationships.
4	identify and describe the strategies for the administration of justice in a multicultural society.
5	demonstrate an understanding of police-citizen partnerships and how this relationship directly affects the causation and prevention of crime.
6	identify and explain key issues that pose potential conflict between diverse communities and the courts, police and corrections.

	Course Outcomes
1	Key Community Policing Components: Students will identify, and describe the components of community policing (Community Partnerships, Problem Solving, and Organizational Transformation), and provide an example for each.



2	S.A.R.A.: Students will describe , and apply S.A.R.A. (Scan, Analyze, Respond, and Assess) problem solving model to a neighborhood problem.
3	The Crime Triangle: Students will identify, and describe the Crime Triangle, and explain how it relates to the reduction of crime.
4	C.O.P.P.S.: Students will identify, and describe C.O.P.P.S. (Community Oriented Policing and Problem Solving) and explain its importance for developing community "partnerships", in order to reduce and prevent crime.
5	Broken window theory: Students will identify, and describe the "Broken Window Theory" and explain how it applies to the maintenance of the good health of a neighborhood.

Assignment Type:	Details
Reading	Reading assignments typically associated with this particular course of instruction may include but are not limited to the following: - Students are required to read an assigned chapter and answer at least two of the chapter review questions. - Students are required to read the assigned chapter and complete a short chapter quiz each week. - Students are expected to read the assigned chapter(s) each week in preparation for classroom discussion.
Writing	 Writing assignments typically associated with this particular course of instruction may include but are not limited to the following: Students identify at least one current course specific criminal justice issue that is in the news (print or electronic), and write a 1-2 page observation paper, relating course content to their response. Students maintain a journal as it relates to the topic instructed in class (reflection) and to make entries during the week that relate to events in the news that are related to Community Relations. Students prepare written documents (outline, test questions, resources and expert interview information) in support of their chosen presentation assignment. Students choose a particular topic that is related to the course of study (prior approval required) and then write a five-page paper regarding the chosen topic.
Homework	 Homework assignments typically associated with this particular course of instruction may include but are not limited to the following: Students are expected to read the assigned chapter(s) each week in preparation for classroom participation. Students are required to read the assigned chapter(s) and define key terms associated with the content of each chapter. Students are expected to do research work and otherwise prepare for their respective presentations as required for this course. Students are assigned a research project that directly relates to the topic of Community Relations.
