Assignment Type:	Details
Reading	Each week students will read an assignmed chapter in the textbook and additional material related to the issue. Their thinking about the issue will be information by their reading and they will ultimately be assessed in an exam or essay.
Writing	Students will write 1,000 words either in one or two papers, using APA style, on a correctional issue, analyzing and explaining the issue. Papers will include accurate citations, spelling and grammar.
Homework	For a typical homework assignment students will read a chapter in the assigned textbook then answer essay, fill in the blank and multiple choice questions.
