Christine Statton proposed the District's intent to use \$2.455M of the Measure I funds to pay-off the Certificates of Participation (COP) from prior parking lot projects. The remaining funds of \$242,000 would be used to renovate the weight room and to install Wi-Fi in the theater. Discussion followed.

Matt Seals moved to approve the District's expenditure of Measure I funds as proposed; Myron Sheklian seconded. Motion carried by unanimous vote.
