Committee Purpose & Bylaws

- The College of Sequoias Community College District was successful at the election conducted under Proposition 39 on November 4, 2008 (Measure J), \$60,000,000 in general obligation bonds.
- Pursuant to Section Education Code Section 15278, the District is obligated to establish an Independent Citizens' Bond Oversight Committee in order to satisfy the accountability requirements of Prop 39.



Committee Establishment & Bylaws

- The Board of Trustees of the District (the "Board") has previously established the Committee which shall have the duties and rights set forth in these Bylaws.
- The Committee does not have independent legal capacity from the District.

- Citizen's Bond Oversight Election
- Term
 - The Chair and Vice-Chair shall serve in such capacities for a term of one (1) year and may be reelected by vote of a majority of the members of the Committee.




