Purpose of the Annual Report

In accordance with Education Code Section 15280, the following report is the fulfillment of the committee's annual requirement.

Measure J was approved by the voters on November 4, 2008. A Bond Resolution was adopted and signed by the Governing Board on June 9, 2008, and is available on the COS website at: <u>www.cos.edu</u> (Click on Measure J Tulare Bond).

Measure J required the creation of a Citizens' Oversight Committee. The purpose of the Citizens' Oversight Committee is to inform the public concerning the expenditure of bond revenues. The Committee is charged with actively reviewing appropriate reporting on the proper expenditure of taxpayers' money for school construction. Citizens' Oversight Committee shall advise the public whether the community college district is in compliance with the requirements of paragraph (3) of subdivision (b) of Section 1 of Article XIIIA of the California constitution.

The Committee is scheduled to meet on October 15, 2012, to review and approve this report and instructed the Committee Chairman or his designee to submit this Annual Report to the Governing Board of the College of the Sequoias Community College District at its regularly scheduled November 13, 2012, meeting.

The audit for the year ended June 30, 2011, was performed by Vavrinek, Trine, Day & Co., LLP, Certified Public Accountants. The Committee members were given a copy of all pages of the 2011 Audit Report that refers to Measure J (General Obligation Bonds 2008). Under Findings and Recommendations, no exceptions were found relative to the General Obligation Bonds.

An annual audit for the year ending June 30, 2012, is being conducted at this time by Vavrinek, Trine, Day & Co., LLP, Certified Public Accountants, and will be completed by December 2012.

Tulare Center Project Status

The project is currently 96% complete and going well. The campus is still scheduled to open for classes in January 2013.

Findings

Based on this information, as of October 15, 2012, the Citizens' Oversight Committee finds that the bond revenues were expended only on the specific projects approved by the voters and that no funds were used for any teacher or administrative salaries or other school operating expenses.

The meeting agendas, minutes, and materials distributed to the Committee are posted on the District's web site and available in hard copy from the President's Office. A notice was sent out to the local media prior to each meeting.
