1. Call to Order

Irene Santos called the meeting to order at 3:06 pm.

2. Public Comments

There were no public comments.

3. Approval of Minutes of September 15, 2015

Not approved – quorum not present

4. Financial Report

Leangela Miller-Hernandez explained that there were no expenditures for the first two quarters of 2015-16 as we are holding the remaining funds to help pay off the BAN (Bond Anticipation Note) that is due by June 30, 2016.

5. Proposition 39 General Obligation Bond Audit Report – June 30,2015

Christine Statton reviewed the audit report. She pointed out that there were no audit findings.

6. BAN Payoff

Christine Statton explained that the BAN debt is approximately \$5.25 million with an additional \$240,000 of interest due. There are issuance costs associated with issuing a new bond, which are estimated at \$275,000. We are also looking at issuing an additional \$1 million to reimburse the Linwood Reserve Fund for the money borrowed to pay the commitment to Corcoran Unified. All of this totals \$6.8 million. We are going to expend the final \$3 million of bond money and interest currently set aside, and issue an additional \$3.8 million dollar bond. The proceeds will be drawn down and spent almost immediately. As a result of the final expenditures the Oversight Committee will wrap things up and there will be no need to continue beyond the final meeting in March 2017.

7. Advertising and Celebrating Completion of Measure J Projects

Christine Statton talked about joining the Crush Party (joint fund raiser with the COS Foundation and Tulare Chamber) where photos could be displayed and a committee member could speak briefly about the projects. Some members don't feel that's the best venue as they want to make a celebration out of it. Christine Statton explained that the District doesn't have funds to host a special event to celebrate the completion of the bond projects. After further discussion it was decided that Chris Lange and Irene Santos will talk with Louann Waldner about joining another event in the fall. Irene Santos will contact Christine Statton with an update on what is decided.
