

## 2017-18 Above-Base Resource Allocation Questionnaire March-April 2018

District-wide feedback is valued and it is integral to our improvement efforts at the College of the Sequoias. As part of the District's planning and evaluation process, the Office of Research, Planning and Institutional Effectiveness designs, develops and administers surveys/questionnaires, as needed. The survey results are analyzed by the office and forwarded to the appropriate administrators and staff for use in advancing the District's mission. During Spring 2018, participants of the Above-Base Resource Allocation review process were invited to participate in the 2017-18 Above-Base Resource Allocation questionnaire.

This report contains a detailed statistical analysis of the results to the survey. The results analysis includes answers from all respondents who took the survey in the 17-day period from March 26 to April 12, 2018. A total of ten responses were received to the survey during this time (10/37).




# Q1 Please specify your participation in the 2017-18 Above-Base Resource Allocation process:
