**COURSE DESCRIPTION:** This 3-day course is designed to assist law enforcement personnel involved in the detection, identification, evaluation and apprehension of person(s) who are suspected of being under the influence of a controlled substance or alcohol.

**COURSE OVERVIEW:** Identification and evaluations of person(s) suspected of being under the influence of a controlled substance and or alcohol that are possible violations of 11550 H&S, 647f PC, or 23152 CVC. Through the use of multimedia, lecture, attendee participation, the Drug Abuse Recognition Card (DAR), and pupil light, the attendees will understand the symptomology of influence caused by the various drugs of abuse and alcohol. Drug and user identification, techniques involving officer safety for dealing with Excited Delirium, report documentation, and Courtroom testimony will be discussed.

**COURSE FEE:** \$125.00 *per participant*. Enrollment is on a first-come basis. Please enroll your personnel as early as possible. Registration fee includes DAR Card, penlight and handouts containing class material. Students are encouraged to bring laptops or tablets to access material in class.
