In partnership with the California Community Colleges (CCC) Chancellor's Office and the California Community College Research and Planning Group (RP Group), the College of the Sequoias (COS) administered the CCC Statewide College Decisions Survey. A special thank you to the Giant Research Team and the COS Foundation. The survey was conducted to gain a better understanding of continuing and prospective students' decisions to attend college, and it is intended to support strategic enrollment management as well as give students a voice in how their college (COS) can best support them. The RP Group provided COS with the survey responses, and the COS Research Office analyzed and summarized the survey data.

Attached for your review and use, is the 2022 California Community Colleges Statewide College Decisions Survey: Survey Results Summary for College of the Sequoias . This report includes the aggregate results for all COS enrolled and prospective students who participated in the survey. Overall, 1,955 COS students (949 enrolled students; 1,006 prospective students) participated in the survey between August 18, 2022 and October 7, 2022. Please share the survey results, as appropriate.

# **Background Information**

The College of the Sequoias participated in the California Community Colleges (CCC) Statewide College Decisions Survey that was conducted by the RP Group, in partnership with the California Community Colleges Chancellor's Office (Chancellor's Office). The survey was conducted to gain a better understanding of continuing and prospective students' decisions to attend college, and it is intended to support strategic enrollment management as well as give students a voice in how their college (College of the Sequoias) can best support them. The survey invite was sent to students enrolled at COS between Spring 2020 and Fall 2022 semesters, and individuals who submitted an application to COS between Spring 2020 and Fall 2022 semesters. Approximately 53,000 invitations to participate in the survey were delivered between August 18, 2022 and October 7, 2022, but some of these were duplicates because invites were sent to students' COS and personal emails. Overall, 1,955 participants selected COS as the main college they enrolled at or planned to attend. Of those 1,668 (85%) were completed responses while 287 (15%) were partial responses. Additionally, of the 1,955 participants who selected COS as the main college they either 1) enrolled at or 2) planned to attend, 48.5% reported being previously enrolled at a California community college.

# **Enrolled Students Survey Results**

# **Student Characteristics**

There were 949 participants who reported to being previously enrolled at a California Community College and selected COS as their main college. These 949 participants are referred to as "Enrolled Students". Approximately 115 to 120 of the enrolled students did not answer demographic questions. Among the enrolled students who answered the race/ethnicity question, over half of the participants identified as Hispanic (57%), and 18% identified as White. Additionally, 15% identified as Multi-ethnic (2+ races/ethnicities selected) while 2% identified as African American/Black. Those that identified as Asian/Asian American accounted for 4% with 1% identifying as Southeast Asian and 3% identifying as Other Asian/Asian American. Three race/ethnic groups accounted for less than one percent combined (American Indian/Alaskan Native [.2%], Middle Eastern/North African/Arab/Arab American [.1%], and Pacific Islander/Native Hawaiian [.1%]). Finally, 1% of the enrolled students selected Other as their race/ethnicity, and 3% selected "Prefer not to answer."

Among the enrolled students who answered the gender question, a majority identified as female (74%), and nearly one in four identified as male (23%). Less than 1% of participants selected non-binary/third gender (.7%) or preferred to self-describe (.1%) which included identities such as gender non-conforming male. Three participants (.4%) selected multiple genders, and 1% of the participants selected "Prefer not to answer."

Only 2% of the enrolled students who participated indicated they were a veteran or active duty service member, while 17% identified as a student with a disability. Half of the enrolled students reported being between the ages of 18 and 24 (50%), and 25% reported being between 25 and 34. Students 35 and older accounted for 25% of the enrolled student participants. See Table 1 for more on enrolled students' demographic characteristics. Among enrolled students, 41% indicated they had dependents, and among those who reported the ages of their dependents, 52% had dependents under the age of five while 36% had dependents between the ages of six and 18. Additionally, 28% had a dependent between the ages of 19 and 64, while 2% had a dependent 65 or older (See Chart 1 and Chart 2). Finally, among the enrolled students that responded, 98% indicated that having a college education was "very important" (81%) or important" (17%).

### Most Recent Term Attended

A majority of the participants reported that their last term attended was Spring 2022 (66%), and 15% reported attending last in Fall/Winter 2022. Nearly one in five participants reported last attending prior to Fall 2021 (19%) (See Chart 3). A majority of the participants reported being part-time in their last term (60%) with 36% taking between 6 and 11.5 units and 24% taking less than 6 units. Additionally, 37% reported being full-time students (12+ units) in their last term, and 3% reported only taking noncredit courses (See Chart 4). Nearly one-third of enrolled students (29%) reported dropping at least one course in their last term (See Chart 5), and among those who did drop a course, the top five reasons for dropping were 1) I could not keep up with the pace of classes (34%), 2) I had to prioritize work (31%), 3) I had to prioritize my mental health (30%), 4) I had dependents who I needed to care for (29%), 5) I could not learn in an online environment (23%). See Chart 6 and Table 2 for the full list of students' reasons for dropping courses.

# Students' Plans for Fall 2022

Nearly all participants reported that they had already enrolled in courses for Fall 2022 (87%) while very few indicated they plan to attend but have not enrolled (4%), they are still deciding (5%), or they do not plan to attend (4%) (See Chart 7). Among those who had not already enrolled in Fall 2022, 111 students reported on the reasons affecting their decision to not re-enroll. The top five reasons affecting students re-enrollment decisions were 1) I cannot afford to pay for college at this time (37%), 2) I will be attending a four-year university (34%), 3) I have dependents who I need to care for (30%), 4) I have already completed a certificate and/or degree (28%), and 5) I have to prioritize work (25%). See Chart 8 and Table 3 for the full list of reasons affecting students' re-enrollment decisions.


Among those that had enrolled, planned to enroll or were still deciding on enrollment for Fall 2022, 874 participants reported on the number of units they planned to take. Almost half of the participants planned to be full-time students (44%) (12+ units), while 55% planned to be part-time students with 36% taking 6 to 11.5 units and 19% taking less than 6 units. One percent planned to only take non-credit courses (See Chart 9).


# Students' Feelings about Campus Climate


Nearly all students report that the campus climate at the college (COS) is supportive for students in general (94%) and for students like them (92%). Specifically, half of the participants reported the campus climate at the college (COS) was "Very Supportive" (50.5%) of students in general, and another 43.5% reported that that the campus climate at the college (COS) was "Supportive" of students in general (See Chart 10). Additionally, 47% reported that that the campus climate at the college (COS) was "Very Supportive" of students like them, while another 45% reported that that the campus climate at the college (COS) was "Supportive" of students like them (See Chart 11).



# **Prospective Students Survey Results**

### **Student Characteristics**

There were 1,006 participants who reported not being previously enrolled at a California Community College but selected COS as their main college in which they planned to attend. These 1,006 participants are referred to as "Prospective Students". Approximately 130 to 140 of the prospective students did not answer demographic questions. Among the prospective students who answered the race/ethnicity question, over half of the participants identified as Hispanic (55%), and 19% identified as White. Additionally, 17% identified as Multi-ethnic (2+ races/ethnicities selected) while 2% identified as African American/Black. Those that identified as Asian/Asian American accounted for 4% with 1% identifying as Southeast Asian and 3% identifying as Other Asian/Asian American. Four race/ethnic groups accounted for one percent combined (American Indian/Alaskan Native [.2%], Indigenous [.2%). Middle Eastern/North African/Arab/Arab American [.5%], and Pacific Islander/Native Hawaiian [.1%]). Finally, 1% of the prospective students selected as Other as their race/ethnicity, and 2% selected "Prefer not to answer."

Among the prospective students who answered the gender question, a majority identified as female (68%) and 28% identified as male. Sixteen participants selected non-binary/third gender (2%), while less than 1% of participants preferred to self-describe (.6%) which included identities such as transgender, trans female, genderfluid, and transsexual male to female. Nine participants (1%) selected multiple genders, and 1% of the participants preferred to not answer.

Only 1% of the prospective students who participated indicated they were a veteran or active duty service member, while 12% identified as a student with a disability. Most of the prospective students reported being between the ages of 18 and 24 (79%), and 11% reported being between 25 and 34. Students 35 and older accounted for 10% of the prospective student participants. See Table 4 for more on enrolled students' demographic characteristics. Among prospective students, 24% indicated they had dependents, and among those who reported the ages of their dependents, 58% had dependents under the age of five while 28% had dependents between the ages of six and 18. Additionally, 25% had a dependent between the ages of 19 and 64, while 2% had a dependent 65 or older (See Chart 12 and Chart 13). Finally, among the prospective students that responded, 97% indicated that having a college education was "very important" (71%) or important" (26%).


# Students' Plans for Fall 2022


Nearly all participants reported that they had already enrolled in courses for Fall 2022 (91%) while very few indicated they plan to attend but have not enrolled (4%), they are still deciding (3%), or they do not plan to attend (2%) (See Chart 14). Among those who had not already enrolled in Fall 2022, 67 students reported on the reasons affecting their decision to not enroll. The top reasons affecting students' enrollment decisions were 1) I am considering another college/university (40%), 2) I cannot afford to pay for college at this time (39%), 3) I have to prioritize work (34%), and 4) I am delaying my college plans (2%). See Chart 15 and Table 5 for the full list of reasons affecting prospective students' enrollment decisions.


Among those that had enrolled, planned to enroll or were still deciding on enrollment for Fall 2022, 995 participants reported on the number of units they planned to take. More than half of the participants planned to be full-time students (66%) (12+ units), while 33% planned to be part-time students with 24% taking 6 to 11.5 units and 9% taking less than 6 units. One percent planned to only take non-credit courses (See Chart 16).




