**What are the strengths of your area?:** Program Knowledge & Campus Partnerships:

COS's Articulation Program had an Articulation Officer, Greg Keen, who served 35 years at COS providing 32 years of support and knowledge in the area of articulation. The longevity of the Articulation Officer position has helped maintain consistency and efficiency with the articulation-related processes and methods. Additionally, the Articulation Officer provided ongoing partnerships and communication with faculty and various student services departments, such as Counseling, Transfer, Admissions and Records, and Evaluations. To ensure up-to-date information was received and shared, the Articulation Officer regularly attended Curriculum Meetings, Counseling Division Meetings, General Education Committee meetings, as well as several campus Task Force. Greg Keen recently retired in July 2022 but during this past academic year, he was able to help the District complete several articulation/curriculum related tasks, such as the project on including leading zeros in ASSIST.

Greg Keen completed the needed modification of College of the Sequoias courses in ASSIST and C-ID to include necessary leading zeros (e.g. NUTR 18 is now NUTR 018) for all one and two digit course numbers beginning 2003-2004. The college has worked diligently to ensure leading zeros are accurately reflected in all publication including our General Catalog, Course Schedule, and transcripts. Due to limitations in Legacy ASSIST, the leading zeros were not added to the database. With the implementation of ASSIST NG we were informed ASSIST would provide a programmatic solution, and since the leading zeros had not presented any difficulties we waited for this opportunity. We have recently been informed that ASSIST would not be able to provide such a solution in the near future. Due to complications with making these changes retroactively, we have followed the recommendation by ASSIST staff to include the leading zeros effective Spring 2022.

The Articulation Program maintains comprehensive and current articulation on the statewide articulation repository (ASSIST.org), and efficiently maintains and coordinates the updating of the transfer general education programs (CSU GE & IGETC). Please see attached for COS's summary of transfer curriculum changes. Additionally, per the data noted below, the efforts of our Articulation Program plays an important role in providing students with more transfer opportunities and helping the College increase its number of Associate Degrees for Transfer (ADT) awarded.

**What improvements are needed?:** At a state-level, comprehensive articulation reviews for all CSU and UC campuses continues to be an area needed for improvement to help ensure date integrity with ASSIST Next Gen and up-to-date articulation. Many CSU and UC campuses have been reviewed and updated but as of May 2022 many still have not been reviewed. Additionally, it's important for all institutions to work towards updating all one and two digit course numbers in ASSIST (Statewide Articulation Repository) to include leading zeros to ensure consistency across the state for transferability of courses. ASSIST informed the field these updates unfortunately cannot be done through a programmatical solution and will need to be done manually, which will lead to a delay in getting this project completed throughout the state.

At a local level (COS), it will be helpful for our new Articulation Officer to work with our Counseling and Admissions and Records department to fine-tune articulation-related processes and make needed updates.

**Describe any external opportunities or challenges.:** While COS has strong articulation agreements with several higher educational institutions, there is a great opportunity to work on increasing the number of articulation agreements as well as updating current articulation agreements.

**Overall SAO Achievement:** SAO from 2021-2022 have been accomplished; all needed modification of College of the Sequoias courses in ASSIST and C-ID to include necessary leading zeros (e.g. NUTR 18 is now NUTR 018) for all one and two digit course numbers beginning 2003-2004 have been completed.

**Changes Based on SAO Achievement:** Due to limitations in Legacy ASSIST, the leading zeros were not added to the ASSIST database. With the implementation of ASSIST NG we were informed ASSIST would provide a programmatical solution, and since the leading zeros had not presented any difficulties we waited for this opportunity. We have recently been informed that ASSIST would not be able to provide such a solution in the near future. Due to complications with making these changes retroactively, we have followed the recommendation by ASSIST staff to include the leading zeros effective Spring 2022.

## Action: 2021-2022 ASSIST and Leading zeros in Course Numbers

The college needs to insure all one and two digit course numbers in ASSIST (Statewide Articulation Repository) are modified to include leading zeros. For example NUTR 018 is standard in our General Catalog, Class Schedule, and Transcripts, but it is currently listed in ASSIST as NUTR 18. ASSIST informed the field years back that they would provide a programmatical solution and now they have informed us that the only option for the foreseeable future is a manual solution.
