What are the strengths of your area?: What are the strengths of your area? The academic year of 2022-2023 continue to show a rise back to the levels we were seeing pre pandemic in regards to calls for service as well as both students and vehicles on campus.

The following areas demonstrate some significant strengths:

- 1. The department has filled all police officer positions and is at full staff. The additional positions now allow for over (90) ninety hours of coverage for both the Hanford and Tulare campuses encompassing both day and night shifts.
- 2. The crime statistics for the District have dropped significantly partly to do with the department being at full staff. Arrests have risen slightly, but they have been almost entirely related to individuals who are non-students experiencing issues involving drug and alcohol abuse, as well as those experiencing homelessness. These stats are reflected in the surrounding cities and counties as well.
- 3. The district transitioned to virtual parking permits for students last year. This year, we implemented the same parking permit system for faculty and staff. In doing so, this has eliminated all sticker permits for the district and had reduced the cost to the District Police for the purchasing and design of the semester/yearly permits.
- 4. The District Police have expanded our Axon Body Camera system by ordering cameras for our patrol cars. These cameras will integrate with our body cameras and record video and audio from the front of the vehicle, as well as have License Plate Reader functions that can scan vehicles on the roadway and parking lots indicating if the vehicle is stolen or wanted for a crime. The system also will add a camera in the rear area of the patrol camera to record any individuals who are detained or under arrest protecting both the district as well as the individual during the length of the contact.
- 5. The department has entered into a contract with Flock Safety for License Plate Reader Cameras on all three campuses. These cameras capture license plates of vehicles that are driven onto district property. These cameras access the stolen vehicle system and can alert officers in real time about stolen vehicles, wanted vehicles, missing persons, and Amber Alerts. Officers can also add vehicles into the system as an "In house" alert for reasons such as criminal investigations, persons of interests and students of concern.
- 6. The department is in the process of obtaining a secure connection to the Tulare County Sheriffs Office for the purpose of connecting to the Department of Justice and "CLETS." These systems will allow the District Police to access numerous state systems that we are currently having to rely on the Sherriff's Department for. We are currently working with TCSO IT, and COS IT on this ongoing project.
- 7. District Police Staff have been working over the last year to redesign our departments shoulder patch. The goal is to design a patch that reflects both the department and the college. When the patch is designed, it is also planned to be a part of the Pink Patch Project raising money for Breast Cancer Research as well as other patches that can be purchased for causes such as Autism Awareness, and Veterans Programs.
- 8. The District Police has upgraded all of their handheld and patrol car radios at the request of the Sheriffs office for inner

agency operability. The Sheriff's Department requested all departments who utilize their dispatch services to make sure their radios are encrypted and digital for security reasons.

What improvements are needed?: 1. The department would like to work on its community outreach and involvement with both on and off campus student and community functions. As part of the Cal. Code Regs. tit. 5 § 59703 (5) require campus police and security officers to attend and participate in campus activities not involving a "police response" or other formal public safety-related activities, such as participating in student events when invited, in town halls, convocations, and other similar events where informal or social interactions with other campus stakeholders is possible. As part of the community outreach program, the District Police would like to advance its community outreach program and attend all student events.

- 2. The department is needing to obtain a digital fingerprint reader to help identify individuals who officers come in contact with, who are unable to identify themselves with either an identification card or another valid for of identification. This technology will assist in identifying individuals who are being investigated or stopped while on district property when officers are unable to positively obtain proof of identification. This can also assist officers with individuals who may being unable to verbally identify themselves, suffering from an illness like dementia or experiencing a medical emergency. Currently when officers are encountered with this issue, they have to rely on assistance from other agencies who may not be available at the time to assist.
- 3. The department has retired its 2010 Ford Crown Victoria patrol car due to age and condition. The vehicle is becoming more expensive to operate and even harder to find parts for repairs. The department needs to obtain one or two reserve vehicles that can be used if a primary patrol car is down for maintenance.
- 4. The department is slowly running out of useful work space for officers within the main District Police Office. Currently there are two work stations inside the officer's work room. At any given time, there is a possibility of having 5 officers on duty at the same time. It would be beneficial to modify inside the department to make better use of space to allow for individual work areas.

Describe any external opportunities or challenges.: The state Chancellors office is implementing Title 5 Campus Climate and Public Safety. There are many challenges and actions that need to be completed by the district police. Many items are already in place, but several are in the process of being implemented such as creating a public safety pact and a community advisory board.

Overall SAO Achievement: One of the SAO's, campus safety and knowledge of the police department continues to be a high priority with the district police. We are working on more effective ways of reaching our community both on and off campus. Recently we conducted a test of our alertus system and sent out a survey to both students and staff and gained valuable feedback on how we are both ensuring our community is notified in emergencies as well as asking what we can do better. This SAO was designed to assess improved campus safety and security and student awareness of police operations on campus, which are key components of a police department's role.

Changes Based on SAO Achievement: These SAO's will continue through 2024 and can be reevaluated each semester or when the next mother load survey is sent out.

Outcome cycle evaluation: The police department has been successful in regularly assessing and updating SAO's each year.

There have been advancement in equipment that can help officers train in realistic setting that are completely safe utilizing "Simunition" firearms that fire a marking projectile similar to a paintball, but still has the weight, sounds, and action of a real firearm.

By utilizing simunitions, this allows for realistic training in a safe and control environment. The resources requested would be safety gear (Head and face protection) as well as simunition pistols that fire marking cartridge's. These converted pistols can not fire real ammunition ensuring safer training. (Active)

Why is this resource required for this action?: With the ongoing threat of school shootings, one time purchase is requested to help further and develop an effective training program to ensure the safety of our district and enhance the knowledge and ability for our officers to respond to these threats.

Currently, these machines only accept cash and coin and are not able to accept credit cards. Currently the district is paying \$1100 a machine for an annual maintenance agreement. This would eliminate this fee and safe the district \$5500 a year. This would also complete an action item of going 100% digital permits in the district.

The new equipment (Keyboard) has been purchased and installed. We are working with the parking enforcement company and the company that handles our permit machines to integrate the systems and bring the new equipment online. Once that is done, we will no longer have the need for paper daily permits.

We have also removed and eliminated the (5) five oldest and outdated machines which has a cost savings of approximately \$4,000 a year for service contracts plus whatever maintenance and paper is needed each year.

Equipment - Non-Instructional - The Mobile Indemnification Device is compromised of a handheld smartphone device. It includes a patented light emitting sensor with large fingerprint capture area ranging from FBI FAP-30 to FBI FAP-50 certification for accuracy. This device enables an officer to quickly and accurately identify individuals. The device will also locate local/state/ and FBI Searches and be able to view record data, arrest history, and mugshots while in the field. (Active)

Rationale (With supporting data): The District Police is recommending upgrading panic buttons in the district to single push usb buttons through Alertus. These buttons plug into computers running the Alertus programming. Currently the district is using wireless panic buttons through our intrusion alarm system. The current system is outdated and not working all the time. Issues regarding batteries dying, buttons being misplaced and difficulties with a wireless signal not transmitting through concrete walls raise concerns for reporting emerges. Another issue is that when a button is pushed, the signal transmits to the alarm company, who then contacts the sheriffs department, who then dispatched the district police. This is to many steps for an emergency. The Alertus system would be a direct contact to district officers in the field with no delay or transferring.
