For hard copy official transcripts included with your application packet: Applicant is required to provide <b>TWO</b> official transcripts (<b>in original sealed/unopened envelope</b>) for <b>any and all</b> U.S. institutions, regardless of applicability to nursing requirements. If you choose this option you are not required to apply to College of the Sequoias. For submission of official electronic transcripts: Applicant must apply to COS first, before sending an official eTranscript(s). Once applicant is issued a Banner ID, the applicant is required to send ONE official eTranscript for <b>any and all</b> U.S. institutions, regardless of applicability to nursing requirements. Be sure you send your eTranscript to College of <b>the</b> Sequoias, Admissions and Records Office. You are required to also include copy of the corresponding unofficial transcripts in with your application, and receipt of electronic transfer is strongly recommended in case of the COS not receiving transcripts by the deadline.</p> <p>Courses completed at other regionally accredited United States colleges or universities must be equivalent to C.O.S. courses. For determination of course equivalency, <b>official transcripts AND course descriptions/ syllabi for prerequisite courses, if necessary for COS evaluator</b>, will be required.</p> <p>All prerequisite courses must be completed with a grade of “C” or better and the final grade must be posted on the transcript. Only one repeat is allowed for each science prerequisite.</p> <p><b>Failure to submit official transcripts with all grades posted will result in disqualification from the application process.</b></p>
